As you may know, all adults of our diocese who interact with minor children in our parishes and schools are required to attend a Protecting God’s Children Training. Also included in developing a safe environment for our children is the training of students enrolled in our elementary, middle and high schools, as well as the students enrolled in the Parish School of Religion and Home Study programs. We are committed to see that every child receives age-appropriate information to keep them safe from abuse. The personal safety program is just another step in teaching children how to be safe such as looking both ways before you cross the street, fire safety, water safety, etc. There are several selections of training methods available.

- training using professional video publications focusing on personal safety at all grade levels. These videos were purchased by the sources listed on the attached sheet. The information is suitable for viewing by students of a faith based organization.
- training conducted by prevention educators from the Illinois Coalition Against Sexual Assault Agency. The prevention educators visiting our schools are trained professionals in conducting awareness sessions using age appropriate information to reach all age groups of children.
- the *Child Lures* program. The Child Lures program is a well structured lesson based curriculum taught by the student’s classroom teacher. The Child Lures program is a program recommended for use by all public elementary and middle schools in the State of Illinois.
